### Hudson River Watershed Stewardship Award Narrative Summary

## **II. Demonstration of results**

Describe how the effort was determined to be successful. Describe any documented improvements to water resources.

How was the effort proven to be effective or successful?

Were valued resources directly improved or protected, such as water quality, wildlife habitat, quality of life, or any other community benefits?

## **III. Community outreach, local involvement and collaboration**

Describe how the watershed community was engaged in the effort.

How was the public involved?

Who contributed technical and financial resources?

Did the effort involve collaboration or consensus? If so, describe.

## **IV. Comprehensive approach to watershed or water resource stewardship and conservation**

Describe the breadth or holistic nature of the effort from all relevant and appropriate perspectives.

Was this interdisciplinary, accommodating varying stakeholder interests?

How broad was the natural resource focus?

## **V. Relevance to local, regional and watershed goals and needs**

Describe how this effort fits into a local, regional and watershed or water resource management priorities.

What is the context of this effort within established initiatives and goals?

## Frequently Asked Questions

### **Who is eligible?**

Any organization or individual that aims to improve or protect the Hudson River watershed's water resources is eligible. This includes river advocates, watershed councils, local and regional government, nonprofits, academic institutions, sportsmen clubs, individuals, and businesses.

### **How will the recipient be selected?**

The recipient will have successfully demonstrated a quality effort based on criteria I-V identified on the nomination summary.

### **How do I submit my nomination?**

### **Where and when will the recipient receive the award?**

The recipient will be awarded the Hudson River Watershed Stewardship Award at the Hudson River Watershed Alliance's annual conference on November 17<sup>th</sup>, 2006.

### **What is the award?**

This is a recognition award by the Hudson River Watershed Alliance providing acknowledgement of the efforts of the recipient. The winner of this award will be featured in a mailed circulation to all HRWA affiliates and a press release. An award will be presented, consisting of a plaque or equivalent.
